I, Chirag Kirtikumar Shah hereby certify that the paid up Equity capital of the Company is Rs. **46,340,000/-** (Four Crores Sixty Three Lakhs Forty Thousand Six only) and the net worth of the company was Rs **44,116,000/-**(Four Crores Forty One Lakhs Sixteen Thousand only) as on 31.03.2019.

And as per Regulation 15 (2) of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 corporate governance provisions as specified in regulations 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and clauses (b) to (i) of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V shall not apply to the following class of companies:

Accordingly it may be noted that the paid up share capital of the Company is below Rs. 10 crore and Net Worth of the Company has not exceeded Rs.25 crore, as on 31st March, 2019 and hence **Corporate Governance is not applicable to the Company for December, 2019.**
